# **Program Overview**

Your company has the opportunity to compete for honors in the construction industry's premier annual awards program – the ABC Carolinas Chapter Excellence in Construction Awards competition – that recognizes outstanding merit shop projects of the year. Use this application and the enclosed forms to enter your company's best project(s).

All award winners will be recognized on November 9, 2023 at the awards banquet in Charlotte, NC. The ceremony will feature a multimedia presentation highlighting Eagle and Merit winners and an elegant, printed program highlighting each award-winning project. Project of the Year and specialty award winners (Carolinas Design-Build and Carolinas Best in BIM) will be recognized in a news release that will be distributed to regional construction-focused media outlets.

# **Entry Requirements**

Each entry must follow the requirements outlined in this award application. You may email questions to eic@abccarolinas.org.

## **ABC Membership**

Only ABC members are eligible to enter. Projects completed through a joint venture must include a document outlining the ownership percentage and responsibilities of each partner. Include this document with the Project Information section. If the majority partner is an ABC member but not all partners are ABC members, only the majority contractor is eligible to enter. If your project was completed by a joint venture and not all parties are ABC members, email eic@abccarolinas.org for eligibility requirements.

#### **Safety Policy**

A company that experiences a safety-related fatality of a direct employee in the United States within the current program year\* is NOT eligible for an Excellence in Construction Award. If a subsidiary is a direct ABC member versus part of a larger holding company member, then the subsidiary with a safety-related fatality is not eligible, but another subsidiary of the same holding company may be. Furthermore, all EIC award winners have a continuing duty to inform ABC of a safety-related fatality that occurred after the end of the current program year until the time of the awards program. Such a fatality will nullify the EIC award. After the judging process and prior to the awards program, ABC will request that an award winner confirm that a safety-related fatality did not occur. Failure to respond to the request will also nullify the EIC award.

A company that experienced a safety-related fatality of a direct employee in the United States within two or three years of the current program year\* is required to provide additional information regarding action that has been taken following the fatality.

No project that involves prime, multi-prime or sub-trade contractors with a safety-related fatality is eligible to be considered for an award.

If there is a question regarding these policies or application requirements, the applicant may request clarification from the Carolinas EIC Committee by emailing <a href="mailto:eic@abccarolinas.org">eic@abccarolinas.org</a> prior to submission of the project application.

## **Project Entry Deadlines**

- **Completion of Project**: Projects must be substantially complete by August 31, 2023 (Projects completed within the last three years—Aug. 31, 2020 Aug. 31, 2023—are eligible to submit.)
- Online Project Registration (Phase 1): Projects must be registered online no later than Friday, August 11, 2023
- **Submission Deadline (Phase 2)**: Entries must be completed online no later than Wednesday, September 20, 2023
- **Project Entry Fee**: Each project must be registered with online payment before being given access to the submission application. No checks will be accepted unless otherwise noted.

# **Overview of Award Categories**

## General Contractor/Specialty Contractor Project of the Year

Project of the Year recognizes a single project that best exemplifies the contributions of quality construction in the Carolinas and is selected from the Eagle Award recipients in both the General Contractor and Subcontractor/Specialty Contractor categories.

#### Eagle Award

The top project in each category is awarded with an Eagle Award. Winners will receive a specially designed eagle sculpture to signify construction's highest honor in each category.

#### Merit Award

Up to three construction projects in each category will be eligible to receive a Merit Award. Winners will receive a specially designed merit award on a base with an engraved bronze plaque.

#### Free Enterprise Award

Free Enterprise Award recognizes the General Contractor with the largest number of ABC members working on the project.

## Carolinas Design-Build

Special recognition is given to a single project that exhibits best practices of the design-build delivery method and how collaborative relationships between project stakeholders advance the practice and profession of the construction industry. To be considered for this award, be sure to complete the Carolinas Design-Build Award section and indicate "yes" in the Project Information section during Phase I.

#### Carolinas Best in BIM

Special recognition is given to a single project that excels in the use of Building Information Modeling (BIM) technology. To be considered for this award, be sure to complete the Carolinas Best in BIM Award section and indicate "yes" in the Project Information section during Phase I.

# **Judging Criteria**

## Read each section carefully.

The panel of EIC judges represents a cross section of construction industry experts, including owners, architects, engineers, and other industry professionals. The competition is comparative, using a numerical points system. A project entry can earn a total possible score of 100 points. The different evaluative sections and their point values are listed below. Answers should be detailed, clear, and informative.

#### **Project Information**

- Company, Contact Title, Contact Name, Mailing Address, Phone Number
- Project name, location (city/state)
- Final contract amount (indicate if this is confidential)
- Did the applying company have a safety-related fatality within the current program year August 31, 2022 August 30, 2023? If yes, the company is not eligible.
- Did any prime, multi-prime, or sub-trade contractor on this project have a safety-related fatality on the project? If yes, the company is not eligible.
- Name of general contractor (if applying company is a specialty contractor)
- Name of client/owner (firm name)
- Start date of construction
- Substantial completion date of construction (To be eligible for award consideration, the project must have been completed within the last two years and must be substantially complete by August 31, 2023.)
- Is this a joint venture? If yes, are all parties within the joint venture members of ABC?

## Contracted Scope (One page max)

(8 points)

- Provide a description of your project scope. This section is intended to be a factual overview of your project. Be sure to include the following details in your summary:
  - Delivery method (CM at-Risk, Design-Assist, Design-Bid-Build, etc.)
  - Total square footage
  - Contact value
  - Duration of project
  - Percentage of self-performed labor

## **Project Narrative (Four pages max)**

(15 points)

Provide a written narrative that tells the story of your project from its beginning to final completion. Your narrative should set the stage for the "Difficulty of Project" section by clearly articulating and describing the factors and characteristics that differentiate your project.

- Describe any innovative programs implemented. Your response may include, but is not limited to, the following topics:
  - Preconstruction/estimating process
  - Scheduling (pull planning, etc.)
  - Value analysis/engineering and budget
  - Quality control
  - o Technology (drones, virtual reality, laser scanning, Building Information Modeling (BIM), etc.)
  - o Project close-out
  - Green building (LEED, Net Zero, WELL Building, etc.)
  - o Diversity, Equity, and Inclusion (DE&I) initiatives such as inno
- What unique factors or distinguishing characteristics differentiate your project from one of similar scope? What makes your project exceptional?

## Difficulty of Project (Four pages max)

(15 points)

- Describe any difficulties, extenuating circumstances, or obstacles you encountered in completing this project and how your team solved them.
- Were any new approaches or innovations developed as a result of these difficulties? If so, what lessons were learned or new processes implemented?
- Describe how you went above and beyond standard practices and protocols to solve your project challenges.

# Quality of Finished Project (Four pages max)

(15 points)

- Describe the end product in detail, referencing site, exterior, interior, MEP, or other pertinent project details.
- How did collaboration with your project partners result in a quality project? Partners include: design, engineering, client(s), general or specialty contractors, community or municipal authorities, etc.
- Include any detailed images not included in "Photographs Section" that exemplify the quality of your work how you went above and beyond standard practices and protocols to solve your project challenges.

## **Photographs**

(5 points)

Submit at least three (3) or a maximum of 10 files below. It is recommended to include photos that are relevant to the challenges and solutions outlined in the narrative. To obtain maximum points, provide "in progress" photos for new construction. Renovation and restoration projects should include "before and after" photos. Provide a descriptive caption for each file. A file may contain multiple images as needed, such as comparative images or before/after photos. Files should be a minimum of 300 DPI and are allowed in the following formats: .jpg and .png. No PDFs are allowed. If any photos being submitted were taken by a third-party photographer, the photographer's written authorization to use the photos is required. In order to comply, you must upload a copy of the signed licensing agreement found on at abc.org/eic with the photographer's signature. No changes are allowed to this document.

## **Project Safety**

(22 points)

- Did the applying company have a safety-related fatality within the current program year- Aug. 31, 2022 Aug. 30, 2023? If yes, your company is NOT eligible.
- Did your company have a safety-related fatality within two or three years of the current program year Aug. 31, 2020 – Aug. 30, 2022? If yes, answer the questions below.
  - What was the violation type as determined by OSHA (i.e. Willful, Serious, Repeated, Other-than-serious, No violation was cited)?
  - Date and location of incident
  - Were there any fines, citations, or penalties issued? If so, by whom (i.e. OSHA, Police, Department of Transportation, etc.)?
  - Provide a written report up to five pages that details the following:
    - A full account of the incident and the investigation
    - What corrective actions were taken immediately?
    - What corrective actions were taken culturally?
    - How was accountability addressed?
    - What procedural changes were made?
    - Was here an overall evaluation of the company safety policies, and if so, what changes were made?
    - If the fatality occurred three years out from this program year Aug. 31, 2020 Aug. 30, 2023, provide details as to how your company has implemented the changes discussed above and how it has affected the overall safety performance.
- Did this project have a safety-related fatality? If yes, this project is not eligible.
- Include your company's OSHA Form 300A (project specific, if available) for the year(s) the project was under construction. If omitted, your company is not eligible.
- Include your company's OSHA Form 300 (project specific, if available) for the year(s) the project was under construction with personal information redacted. If omitted, your company is not eligible.
- Is your company STEP Safety Management System Participant for 2022? If yes, provide a copy of the certificate.
- Does your company have a written Safety and Health Policy Manual? If yes, provide the table of contents or a summary. If no, this project is not eligible
- Were toolbox safety meetings held with employees? If yes, were these meetings documented and what was the frequency of meetings? Include a one-page summary or an example up to two pages.
- Was specialized training conducted on this project? If yes, include a description of the specialized training.
- Indicate total man-hours for all disciplines included in your contract on this project.
- Indicate the number of OSHA-recordable accidents on this project.
- Indicate the number of OSHA lost-time accidents on this project.
- Indicate the number of OSHA restricted day cases on this project.
- Has your company signed the Construction for a Drug-and Alcohol-Free Workplace's pledge at www.drugfreeconstruction.org? If no, this project is not eligible.
- Does your company have a substance abuse policy? If yes, provide a copy of the table of contents or a one-page summary of your company's substance abuse policy.
- Include any additional information regarding any innovative safety and health programs used on this project or the company's overall safety program.

#### References

(10 points)

• Include letters of recommendation from third parties involved with the project, such as the owner, general contractor, architect, engineer, and design team.

For general contractors, if the owner is unable to provide a letter of recommendation due to company policy, upload a letter from the owner's letterhead stating they are unable to provide a reference. Up to three letters may be uploaded.

## **Supplemental Materials**

(5 points)

Provide any miscellaneous supporting materials such as diagrams and other graphics; traditional media and/or social media coverage; other awards and community promotion; as well as multimedia including audio, video, and other interactive content. Audio and video files should be uploaded in one of the following three file formats: 1) .mov 2) .avi 3) .mp4

Please note that **no additional points** will be awarded for audio, video, and other interactive media content. These files will be given the same consideration as other types of supporting project material.

You may upload up to five single files.

#### **Merit Shop**

(3 points)

 With regard to your scope of work, please provide a list of all ABC members (specialty contractor/suppliers/associate) involved in the project. Verify ABC members at <a href="www.abccarolinas.org">www.abccarolinas.org</a>.

#### AQC

(2 points)

- If your company is designated as an ABC 2022 Accredited Quality Contractor (AQC) member, upload a copy of the company certificate. The certificate must indicate the chapter that you are submitting your project through since AQC membership is chapter specific. If necessary, a copy of the certificate may be requested by emailing <a href="AQC@abc.org">AQC@abc.org</a>.
- For more information about AQC and to download an application, visit <a href="mailto:abc.org/aqc">abc.org/aqc</a>. Note that AQC status is not required to submit for an Excellence in Construction award.

## **Short Summary**

Provide a short summary about your project and what features and/or building elements make it noteworthy. Your statement should not exceed 65 words. This will equate to approximately two (2) to four (4) sentences. While you may incorporate your project's scope and/or value, please focus this summary on the constructability details that differentiate your project. Samples have been provided below.

**Please note**: If you are selected as an EIC winner, your "Short Summary" will be incorporated word-for-word in this year's EIC Banquet Brochure and PowerPoint presentation. Please verify details with project partners before submitting your entry, as changes cannot be made after the fact.

## **Project Entry Qualifications, Rights, and Agreement**

- Property All entries become the property of Associated Builders and Contractors (ABC) Carolinas Chapter.
- Entry Category Reassignment ABC Carolinas Chapter reserves the right to alter a project's original entry
  category if it is determined that the project is better suited for a different category and/or its chances to win an
  award will be enhanced by doing so. ABC Carolinas Chapter also reserves the right to redistribute the contract
  volume levels within a category.
- Grant of Rights The applicant hereby grants to ABC Carolinas Chapter the following non-exclusive rights: the right to reproduce and distribute copies of the work throughout the year as part of the competition materials described above, including the right to reprint the work, or any part thereof, whenever necessary and to license the use of the work, or any part thereof, in any medium or form of communication; and the right to use the applicant's name, photographs and biography, in connection with the work. The applicant reserves all rights not specifically granted herein.
- Safety Provision No project that involves a prime, multi-prime, subcontractor or any trade-related work, regardless of the type of contract, that has a safety-related fatality, is eligible for an award.

  will provide winners with photograph(s) from the awards ceremony within several weeks after it takes place.

# **Specialty Awards**

## Carolinas Best in BIM Award (optional bonus award)

More and more, contractors are harnessing the power of Building Information Modeling (BIM) technology and processes to further excellence in every stage of construction. In efforts to highlight exemplary BIM case studies that demonstrate how innovation and technology can advance the profession and practice of construction while furthering the mission of the Associated Builders and Contractors (ABC) Carolinas Chapter, the Best in BIM Award is designed to honor projects that excel in the guidelines set forth below.

Responses will be judged on the following:

- Documented and quantifiable benefits addressing cost, schedule, quality, constructability, and/or safety
- Effective team collaboration and/or new processes used to realize project goals
- Project's success in advancing the theory and practice of BIM use.

**Question One** – How did the use of BIM increase efficiency on your project throughout the construction process? Your answer should address all phases of work including but not limited to preconstruction, sitework, MEP coordination, structure, and final close out. (25 points)

Question Two – What potential issues and conflicts were unearthed during coordination meetings? (15 points)

**Question Three** – Did the operations team fully implement the BIM model during construction? How did the team ensure integrity of the model throughout construction? (10 points)

Question Four - How effective was BIM at driving team collaboration throughout your project?

**Question Four A** – Was the owner fully engaged in the BIM process? Describe with specificity the owner's level of involvement from the beginning to the end of the project, highlighting benefits to the entire team (5 points)

**Question Four B** (For General Contractor Entrants) – Was the subcontractor base fully engaged in the BIM process? Describe with specificity subcontractors' level of involvement from the beginning to the end of the project, highlighting benefits to the entire team. (5 points)

(For specialty contractor entrants) – Was the general contractor fully engaged in the BIM process? Describe with specificity the general contractor's level of involvement from the beginning to the end of the project, highlighting benefits to the entire team. (5 points)

**Question Four C** – Was the designer fully engaged in the BIM process? Describe with specificity the designer's level of involvement from the beginning to the end of the project, highlighting benefits to the entire team. (5 points)

Question Five – Describe the accuracy of the final as-built model (10 points)

**Question Six** – In addition to BIM, what innovative technological tools did your project implement? Your answer may include software, applications, laser scanning, drones etc. How did these tools enhance the quality, constructability, and safety of the project? (10 points)

## Carolinas Design-Build Award (optional bonus award)

Carolinas Design-Build Award highlights construction efforts that exhibit best practices of the design-build delivery method and how collaborative relationships between project stakeholders advance the profession and practice of construction.

Responses will be judged on:

- Documented and quantifiable benefits addressing how the design-build delivery process influenced project results and achieved the owner/user's goals.
- Proof that the design-build process drove successful cost and schedule execution through relationships, transparency, and thoughtful team integration.
- Project's success in advancing the design-build delivery method, with special emphasis placed on the team's use of innovative practices to add value.

**Question One** (15 points) – Describe the design-build entity, the contractual relationships, and the level of risk assumed by the design-build entity. Include a copy of the project's organizational chart that clearly demonstrates the team's structure, including but not limited to, the following entities:

- Contractual design-build team leader
- General contractor
- Architect(s)
- Engineer(s)
- MEP designer(s)/contractor(s)
- Owner/developer
- Other design-build team members significant to submittal

**Question Two** (15 points) – Describe the contracting approach used between the design-builder and owner to achieve a single point of responsibility. How did this approach benefit the owner throughout the lifecycle of the

project from award of the contract to the completion of the facility? Your answer should provide specific examples rather than generalities.

**Question Three** (40 points – each subcategory worth 10 points) – Collaboration is the very foundation of the design-build process. Projects utilizing this delivery method cannot be successful unless the various partners form a fully integrated, cross-functioning team that develops mutual solutions for a project's needs. This section provides an opportunity to highlight team performance.

- Project Team: What methods or approaches were employed to engage and interact as "one team" throughout the project?
- Did the design-builder facilitate early integration of key team members? How and why were key partners selected, and at what stage of the project were they brought on board?
- Describe the owner's involvement in the design-build process. What were some of the benefits to the owner of relying upon a single entity driving a unified flow of work from concept through completion?
- If the collective team had a mission statement, what would it be?

**Question Four** (15 points) - Did the design-build delivery method drive scheduling efficiencies on this project? For example, were long-lead materials and/or equipment pre-purchased in the design process, saving time during construction? Provide specific examples, including but not limited to, whether the team met or exceeded the contracted completion date.

**Question Five** (15 points) – Did the design-build delivery method provide the owner with enhanced cost performance on this project? For example, were there fewer change orders resulting from more complete field data and earlier discovery of design errors or omissions that may have been identified for the first time during the construction phase? Your answer should fully address/explain any numerical data provided.
